

GEOGRAPHY: NATURAL GEOGRAPHICAL AND CLIMATE CONDITIONS



Donetsk region is situated in the South-Eastern part of Ukraine. In the South-Western and West it borders on Dnipropetrovsk and Zaporizhzhia regions, in Northern-West on Kharkiv region and in Northern-East on Luhansk region, in the East on Rostov region of the Russian Federation, in the South it is washed by Azov Sea. The territory of the region stretches from north to south over 240 km and from east to west over 170 km. The total area of the region makes up 4,4% of the total territory of Ukraine.

Northern and central parts of the region are Donetsk Ridge, Southern part is Pryazovska Upland. The highest altitude marks within Donetsk Ridge are 200-260 meters. The highest point is the mountain Saur-Mogyla, it is 277 m high. The range of altitude in these regions measures up 200 m.




SCIENCE AND INNOVATIONS


STRUCTURE OF SCIENTIFIC RESEARCH PROJECTS AND DEVELOPMENTS EXPENDITURE, 2018


NATURAL ENVIRONMENT PROTECTION

Donetsk region is a powerful industrial region where historically the largest development have enterprises of metallurgical and chemical complexes, machine building industry and mines. Therefore, the main efforts are directed at the implementation of environmental measures such as:

- solving of complex environmental problems of the region including improvement of the situation concerning the atmospheric air protection;
- restoration of the hydrological regime and sanitary condition of water objects by implementing measures to fortification of the coast and clearing river channels, as well as construction and reconstruction of treatment facilities;
- increase in the number of objects and area of the nature reserve fund;
- reduction of pollutants emissions into the air from stationary sources of pollution;
- solid household waste management solving problems.

EMISSIONS OF POLLUTANTS FROM STATIONARY AND MOBILE SOURCES, THOUSANDS TONS PER YEAR




Information on observation posts measurements of atmospheric air and daily average concentrations in the last 30 days is constantly posted online on the official site of the Department of Ecology and the natural resources of the regional state administration.

The main pollutants of atmospheric air in the region are enterprises of ferrous metallurgy, thermal power plants and enterprises of the coal industry.


In the region a number of programs and events are being implemented to reduce pollutants in the atmospheric air.

There is an environmental impact computer system in the region. The system of automated atmospheric air monitoring in Donetsk region complies with requirements of EU Directives (2008/50/EU, 2004/107/EU) and includes 7 stationary posts (in Kramatorsk, Bakhmut, Kurakhove, Mykolaivka, Novoluhansk and 2 posts in Mariupol)» and two mobile environmental laboratories for the determination of atmospheric air pollution in cities and districts of the region.


GENERAL QUANTITY OF PRODUCED AND DISPOSABLE WASTE I-IV CLASS OF DANGER, MILLION TONS




FORMATION AND ACCUMULATION OF DOMESTIC WASTES, THOUSAND TONS

FORMATION AND UTILIZATION OF INDUSTRIAL AND DOMESTIC WASTE

The existence of mining, metallurgy, energy and other industries leads to the accumulation of large volumes of industrial waste. The utilization level of industrial waste is about 20% of the formed.

The region has a high population density of 160 people per 1 km², which leads to the formation of a significant amount of household waste.

It is planned to create a network of 4 regional waste recycling centers and 5 regional waste management complexes, which will include regional disposal sites (landfills) of solid domestic waste, waste sorting and waste dumping stations, waste processing enterprises, as well as landfill reclamation which have exhausted their resources.

PROTECTION OF WATER RESOURCES

For the purpose of the crisis monitoring, gauging stations are operated in the experimental operation mode to ensure systematic observations of hydrological and hydrochemical indicators of surface water bodies in substandard-risk zones in the basin of Siverskyi Donets river (2 gauging stations are installed on Siverskyi Donets river) and seawater status (there was installed equipment in Mariupol). Information about the measurements is also displayed online on the official site of Ecology and Natural Resources Department of the Regional State Administration.

DEVELOPMENT OF NATURE RESERVE FUND

In recent years, the number of the objects and area of the nature reserve fund has constantly increased.

TOURISM

Donetsk region is an industrial land, which, at the same time, has a wonderful natural recreational potential. 39% of trips around the region are related to excursions, leisure, festivals and sports and health tourism. The region has over 106 territories and objects of the nature reserve fund.

The sphere of service of tourists includes more than 258 collective accommodation facilities (including 64 hotels and 194 other other temporary accommodation facilities), 33 tourist operators and agents.

Great recreational area of Svyatogiria – "National Nature Park "Holy Mountains" – located in the picturesque valley of the river Severskyi Donets, whose water retains ancient secrets from the time of "The Lay of Ihor's Campaign". Unique buildings on the chalky rocks of Svyatogorsky Cave Monastery and the unique beauty of the National Nature Park "Holy Mountains" are called Donetsk Switzerland.


During the excursion tourists visit production workshops, see a stack of bottles aged for many years, will be able to taste wine.

Another unique enterprise is a state-owned "Artemsil" is one of the largest suppliers of salt to the world market, whose product is supplied to 22 countries of the world. The excursion route takes place at a depth of 288 meters on the worked galleries of the mine. Visitors get a unique opportunity to walk along the bottom of the ancient world ocean, visit the labyrinths of the underground salt kingdom, and see salt sculptures made by craftsmen, salt football field and a unique concert hall that impresses with its size and amazing acoustics.

In addition, the tour has a tremendous therapeutic effect, as it replaces 15 inhalation procedures!

INDUSTRY

Donetsk region is one of the most industrially developed regions of Ukraine, where more than 500 industrial enterprises operate. Each year they produce products worth more than 300 billion UAH.

The basis of the industrial complex is the mining and metallurgical complex, which creates approximately 54% of all industrial products in the region. The mineral-raw material base of the region is almost 50% consists of energy minerals (coal, gas methane coalfield and natural gas), the main part of which is coal.



INDUSTRY

METALLURGICAL COMPLEX

The metallurgical complex is a strategically important component of the economy of the Donetsk region. It consists of enterprises of ferrous and nonferrous metallurgy, coke chemical, refractory, flux producing enterprises. The metallurgical complex employs 39 thousand people. The leading enterprises are: PJSC "Mariupol Metallurgical Combine (Complex, Kombinat) named after Ilich", PJSC "Metallurgical Combine (Complex, Kombinat) "Azovstal", LLC "Elektrostal" (Kurakhovo), LLC "Nonferrous Metals Plant", LLC "Kramatorskyi Ferroalloy Plant", LLC SMA (Scientific and Manufacture Association), PJSC "Chasivoiarskyi Vognetryvkyi (Refractory) Combine (Complex, Kombinat)", JPSC "KDZ" (Krasnoarmiyskyy Dynasovyi (Silica/Dinas) Plant), PJSC "Novotroitske Rudoupravlinia".

Metallurgical enterprises of the region specialize in production of cast iron, steel, metal-rolling products. LLC "Non-ferrous Metals Plant" manufactures products made from non-ferrous metals. Coke plants are specialized in the production of coke and chemical products of coking (ammonium sulfate, coal tar, benzene, pure rectification products). Refractory enterprises produce alum inosilicate, dinasic refractories, unformed materials, extract refractory raw materials - clay and forming sand.



ENGINEERING





FOREIGN TRADE OF GOODS IN DONETSK REGION




GEOGRAPHICAL STRUCTURE OF FOREIGN TRADE IN GOODS IN 2018




COMMODITY STRUCTURE OF EXPORT







SMALL AND MEDIUM-SIZED ENTERPRISES

"The Regional Program for Small and Medium-Sized Business Development in Donetsk Region for 2017-2018" is being implemented in the region, which aims to create favorable conditions for the development of small and medium-sized enterprises, ensuring employment of the population, and increasing the competitiveness of small and medium-sized enterprises.

As part of program activities, work is underway to implement state regulatory policy, provide financial, credit, logistical, informational and consulting, personnel support of small and medium enterprises.

Starting in May 2017, a pilot project on financial support for small businesses started with the aim of creating a class of small and medium owners in all economic spheres. The project is intended to lay the groundwork for the demonopolization of the region's economy through the formation of a new class of entrepreneurship on the basis of a cluster business model and to facilitate the construction of newly formed territorial communities on the principles of self-sufficiency. Financial support is provided on a competitive basis on a gratuitous and irrevocable basis:

General project value

up to 75% at the expense of local and regional budgets

25% and more money of small and medium-sized businesses

70% funds of the regional budget

30% funds of the local budgets

During 2017-2018, according to the results of the competitive selections, 187 business entities received irrevocable financial support in the amount of 78 million UAH funds of regional and local budgets.

There were held training visits of entrepreneurs-winners of competitive selection abroad in order to gain international experience, skill enhancement of Donetsk region small enterprise representatives in the business sphere.

Participants of these training visits were reimbursed for the compensation of expenses related to their stay in these countries (transport, accommodation, insurance, etc.).

TAXPAYERS SERVICE CENTERS

23 service centers operate in the region in order to improve the quality of service and create comfortable conditions for taxpayers.

The list of administrative services provided at the Taxpayers Service Centers of territorial bodies of Chief Administration of State Fiscal Service in Donetsk region:

- 1. Issuance of a taxpayer card and the inclusion in the passport of a citizen of Ukraine (in the form of a booklet) data on the registration number of the taxpayer's card from the State Register of Individual-Taxpayers.
- 2. Entering in the passport of a citizen of Ukraine (in the form of a booklet) the marks about the right to carry out any payments according to the serial number and passport number.
- **3.** Issuance of information from the State Register of Individuals-Taxpayers on the Amounts/sources of paid income and withheld taxes.
- 4. Registration of payment transaction logger.
- **5.** Registration of accounting books for settlement operations.
- 6. Registration of settlement books.
- 7. Inclusion of a non-profit enterprise (institution, organization) in the Register of non-profit institutions and organizations.
- **8.** Re-registration of a non-profit enterprise (institution, organization) in the Register of non-profit institutions and organizations.
- **9.** Certificate issuance of income tax (income) paid by a non-resident in Ukraine.

- **10.** Confirmation of a tax resident status of Ukraine.
- 11. Registration of a single tax payer.
- **12.** Granting extracts from the register of single tax payers.
- **13.** Registration of income tax accounting books and accounting of income and expenses for single tax payers.
- **14.** Registration of a register of income and expenses accounting conducted by individual entrepreneurs, except those who chose a simplified taxation system, and individuals who carry out independent professional activities.
- **15.** Certificate issuance about the submitted declaration of property status and income (tax return).
- **16.** Issuance of personal income tax payment certificate of a taxpayer a resident who travels abroad to a permanent place of residence and absence of any tax liabilities.
- **17.** Issuance of a certificate about absence of arrears from payments to the budget, which are controlled by state fiscal service authorities.

In addition, payers have the opportunity to report, correspond with the SFS authority in electronic form, receive information about their income and paid taxes, as well as receive information on contact details and addresses of service centers, etc. via "Electronic Cabinet of Payer".

CUSTOMS POSTS

There are 9 customs posts in the region, which carry out the processes of customs clearance of goods from the crossing of the border to payment of customs payments and their release into free circulation on the territory of Ukraine.

The main feature of the posts:

- customs posts and checkpoints carrying out custom clearance of goods belonging to citizens and vehicles for commercial purpose, which are transferred by subjects of foreign economic activity within the territory of Donetsk region;
- checkpoint for maritime traffic.

- **8.** Cancellation of the permit for the opening and operation of the customs warehouse at the request of the entity.
- **9.** Granting permission for the opening and operation of a free customs zone of commercial or service type.
- **10.** Reopening of the permit for the opening and operation of a free customs zone of commercial or service type.
- **11.** Suspension of the permit for the opening and operation of a free customs zone of commercial or service type by the statement of economic entity.
- **12.** Cancellation of the permit for the opening and operation of a free customs zone of commercial or service type by the statement of economic entity.
- **13.** Issuance of a certificate of approval about the road transportation for the carriage of goods sealed and bonded by custom.
- **14.** Certificate validity extension about approval of the road transportation for the carriage of goods sealed and bonded by custom.

Permission of using subsoil

Permits for subsoil use are provided by the State Service of Geology and Mineral Resources of Ukraine to the winners of auctions with their sale and without auctions in cases, stipulated by paragraph 8 of the Procedure for granting special permits for subsoil use, approved by the Resolution of Cabinet of Ministers of Ukraine as of May 30, 2011 No. 615.

Permissions are granted for the following types of subsoil use:

- geological exploration of mineral resources;
- geological study including experimental industrial development of mineral resources of national importance;
- mining of minerals;
- geological study of oil and gas minerals including experimental and industrial development of minerals with further extraction of oil, gas (industrial development of deposits);
- construction and exploitation of underground structures, not related to the extraction of minerals including the number of facilities for underground storage of oil, gas and other substances and materials, disposal of harmful substances and waste products, wastewater discharge;
- creation of geological territories and objects with an important scientific, cultural, sanitary and recreational values (scientific polygons, geological reserves, nature reserves, health resorts, health resorts institutions, etc.);
- execution of works (implementation of activities) provided for a product sharing agreement.

Land use permit

Citizens and legal entities acquire property rights and land use rights from state or communal land property by a decision of the executive authorities or bodies of local municipality within their powers determined by the Land Code or by auction results.

- Village, town and city councils transmit land plots owned or used by land communal property of the respective territorial communities for all needs;
- Regional, district councils transmit land plots in ownership or use from appropriate lands of joint ownership of territorial communities for all needs;
- District state administrations transfer land plots from land of state property (land industry, transport, communication, water fund etc.) owned or used within the villages, settlements, cities of district significance for all needs and outside of settlements for water farms; construction of facilities related to servicing residents of the territorial community district (schools, cultural establishments, hospitals, trade enterprises, etc.).

Chief Administration of State Geodetic Cadastre in Donetsk region in accordance with Part 4 of Article 122 about the Land Code of Ukraine transfers agricultural land plots owned by the state for agricultural needs within norms of Art. 121 of the Land Code of Ukraine and in accordance with the order of the gratuitous privatization of land plots by citizens (Article 118 about the Land Code of Ukraine).

According to the Ordinance of Cabinet of Ministers of Ukraine dated January 31, 2018, No. 60-p since February 1, 2018, the State Geodetic Cadastre has started works on the transfer of all agricultural land plots owned by the state into communal property of corresponding territorial amalgamated communities, except those of the land plots that can not be transferred to the communal property.

By the time of transfer of agricultural land owned by the state into communal property disposal of agricultural lands by transfer for use (solely by way of holding auctions) or in the property, is carried out for agreement with the amalgamated territorial communities and after making their own decisions.

With information concerning the available agricultural land plots owned by the state that is included in the list of land plots, the rights to which will be exposed on land trades (auctions) by the Chief Administration of the State Geodetic Cadastre in Donetsk region can be found on the official website site land.gov.ua.


